2114. <u>BOARD MEETING MINUTES</u>

Minutes of November 13, 2018 (Special Meeting/LSIC), November 15, 2018 (Special Meeting/LSIC), November 19, 2018 (Special Meeting/Board Work Session), and November 20, 2018 (Regular Meeting) are being presented for approval.

2115. APPROVAL OF THE CONTRACT FOR THE DEMOLITION OF ENSLOW MIDDLE SCHOOL –

The Superintendent recommends approval of a contract with Reclaim Company, LLC as the winning bid for the demolition of Enslow Middle School in the amount of \$342,888.00. Award of contract is contingent on Huntington City Council first approving abandonment and redirection of alley currently dividing Enslow property. The funding source for this expenditure will be SBA and Local funding.

NOTE: The school trip request below was inadvertently listed as being a trip for Huntington Middle School on the November 20, 2018 agenda instead of Huntington East Middle School.

2116. SCHOOL TRIP REQUEST – HUNTINGTON EAST MIDDLE SCHOOL

The Superintendent recommends the approval of Huntington East Middle School's trip request for 8th grade students to travel to Washington, DC on May 19-21, 2018, for an educational trip. Two (2) days of school will be missed and 90 students along with several chaperones as well as parents will be on this trip. E.T. Advisor Services, LLC will be assisting the school. Expenses will be paid from school funds.

2117. SCHOOL TRIP REQUEST – HUNTINGTON HIGH SCHOOL

The Superintendent recommends approval of Huntington High School's trip request for the Speech and Debate students to travel to Bowling Green, KY on December 7-9, 2018 to participate in a competition. One (1) day of school will be missed and 32 students along with their teacher and several chaperones will be on this trip. Transportation will be provided by the teacher and chaperones. Expenses will be paid from school funds.

2118. SCHOOL TRIP REQUEST – HUNTINGTON HIGH SCHOOL

The Superintendent recommends approval of Huntington High School's trip requests for the Wrestling team to travel to Christiansburg, VA on December 15, 2018 to participate in the Christiansburg Wrestling Tournament, to Barnesville, OH on December 17-18, 2018 to participate in the Barnesville High School Wrestling Tournament, and to Lakewood, OH on January 4, 2019 to participate in the St. Edward High School Wrestling Quad. One-half day (PM) of school will be missed on the trip to Barnesville, OH; otherwise, no school will be missed on the other two trips and 14 students along with three (3) coaches as well as parents will be on these trips. Transportation will be provided by the coaches and parents. Expenses will be paid from school funds.

2119. <u>INTERAGENCY AGREEMENT BETWEEN CABELL COUNTY SCHOOLS AND MEDICAL CENTER/SMMM</u>

The Superintendent recommends approval of an interagency agreement between Cabell County Schools and Medical Center/SMMM (St. Mary's Medical Management), a medical facility in Cabell County, West Virginia, that affords Cabell County students enrolled in the Health Science Academies at Cabell Midland High and Huntington High an opportunity to observe and gain clinical training and practical experience at their facility.
